- Retirement of Mr. Reynaldo A. Maclang as Director, President and CEO of the Bank, effective at the close of business hours on November 15, 2018, and his appointment as Board Advisor, effective November 16, 2018;
- 2. Election and appointment of Mr. Jose Arnulfo A. Veloso as Director, President and CEO of the Bank, vice Mr. Reynaldo A. Maclang, effective November 16, 2018; and
