We wish to inform the Commission that during its meeting held on May 23, 2014, the Board of Directors approved and confirmed the resignation of Mr. Rafael Z. Sison, Jr., First Senior Vice President and Head of Branch Banking Group, effective May 1, 2014.

This number includes the 423,962,500 common shares (the "Shares) deemed issued to the stockholders of Allied Banking Corporation (ABC) relative to the merger of PNB and ABC as approved by the Securities and Exchange Commission (SEC) on January 17, 2013. The shares are the subject of the Registration Statement filed with SEC and for listing with the Philippine Stock Exchange. This also includes a portion of its Stock Rights Offering (Offer) of 162,931,262 common shares (Rights Shares), particularly 33,218,348 Right Shares, which was sourced from the existing authorized but unissued capital stock. The remaining 129,712,914 Rights Shares subject of the Offer will be sourced from an increase in authorized capital stock of the Bank and have therefore not yet been issued.

The Bank also received advice from the Bangko Sentral ng Pilipinas (BSP) of the approval of the Bank's application for a Type 2 Limited Dealer Authority to engage in non-deliverable foreign exchange forwards and interest rates swaps, effective upon the satisfactory compliance with the conditions and requirements of the BSP.

We trust you will take note accordingly.
