PNB Amended Articles of Incorporation:

SECOND. Its principal office and place of business shall be in the National Capital Region, also known as Metro Manila. It may open and/or maintain other branches, agencies or other offices at such places in the Philippines or abroad as its Board of Directors may deem available, with the prior approval of the Monetary Board of the Bangko Sentral ng Pilipinas.

PNB Amended Articles of Incorporation:

SECOND. Its principal office and place of business shall be at PNB Financial Center, President Diosdado Macapagal Boulevard, Pasay City, Metro Manila.
